### Fauna & Flora

Fauna & Flora saves species from extinction and habitats from destruction, while improving the livelihoods of local people. Our guiding principles are to work with and alongside local partnerships, act as a catalyst for change, make conservation relevant, and base decisions on sound science. Founded in 1903, Fauna & Flora is the world's longest established international conservation body; our conservation work, and impact, spans the globe.

## **Asia Pacific Programme**

Working closely with local partners, the Asia-Pacific Programme currently includes a broad range of species and landscape targeted conservation initiatives in Cambodia, Indonesia, Vietnam, and Myanmar, and has country programme offices in Phnom Penh, Jakarta, Hanoi and Yangon. Around 70 projects are being implemented in the region by a team of approximately 200 staff, consultants, volunteers and partner organisations with an annual regional budget of approximately USD 10 million.

### **Lower Mekong Landscape Programme**

Fauna & Flora is about to begin a new programme of work within the Lower Mekong Landscape covering more than one million hectares of the Annamite mountains, incorporating three large forest complexes and encompassing Cambodia, Laos and Vietnam. Funded by the Biodiverse Landscapes Fund (BLF), the overarching aim of this programme is to reduce poverty and create sustainable economic opportunities for those communities, through the delivery of lasting landscape protection, sustainable management, and restoration, safeguarding biodiversity, and maintaining and improving ecosystem quality.

The programme will be implemented through a consortium of highly experienced INGOs, led by Fauna & Flora, and includes SNV, IUCN and Re:wild, working in close collaboration with local partners and Indigenous peoples and local communities (IPLCs), to ensure activities respond to locally identified and prioritised needs. The programme will take an integrated focus on people, nature, and climate, recognising that benefitting one at the expense of the others is inherently unsustainable. This position provides the opportunity to take a leading role in driving forward this transboundary programme of work and bringing this vision to fruition.

### The Opportunity

Fauna & Flora is seeking a highly experienced conservation and/or development professional with experience in running large statutory projects to provide leadership, effective management and delivery of the BLF Lower Mekong Landscape programme within the Asia-Pacific Programme. You will work with Consortium Partner Focal points, BLF Fund Managers, the Independent Evaluator, Country Programme Directors and Fauna & Flora's cross-cutting technical teams to ensure that the most appropriate technical knowledge and experience inform the design and delivery of our work.

We are looking for an individual who has successfully run DEFRA, USAID or EU projects before. You will have a demonstrated commitment to biodiversity conservation and poverty reduction, high-

level technical knowledge, excellent writing skills, and on-the-ground experience working in biodiversity conservation and/or development in Southeast Asia. Your ability to manage integrated landscape - level programmes, diverse teams, deliver complex projects and harness knowledge effectively for adaptive management will be essential to this role. You will be able to build collaborative relationships and working arrangements across remote diverse and dispersed teams, demonstrating cultural awareness and sensitivity. You will be confident working with partner organisations, funders, and other relevant stakeholders.

You will have a substantial proven track record in managing high-level statutory-funded programmes and be skilled in providing strategic advice and technical input to the design, development, implementation, evaluation and reporting of projects.

Highly effective leadership and people management skills are essential to the role to ensure a professional and motivated team that delivers effectively against project aims, objectives and timelines. The role also requires a skilled and credible communicator, who is confident in developing and managing relationships internally, and externally with partner organisations and relevant stakeholders, including donors and funders.

You will be able to demonstrate an understanding of the statutory and regulatory frameworks within which Fauna & Flora operates, as well as a commitment to organisational, donor and legal compliance. You will have an advanced degree or equivalent level qualification in a relevant discipline and/or substantial experience in a related role. Experience working in the South-East Asia region is desirable.

This position is funded in a partnership programme, final appointment is contingent upon final confirmation of funding.

#### **Purpose:**

To ensure the effective management, implementation, technical leadership and overall quality assurance of the DEFRA-funded Biodiverse Landscapes Fund (BLF): Lower Mekong Landscape Programme, guaranteeing that the project follows Fauna & Flora's mission and vision and accords

with policy, procedures and standards, is effectively monitored, and has long-term strategies for sustainability, engagement and fundraising.

To work closely with the Director of Operations, Asia-Pacific, the BLF Consortium Partners, the Country Directors of Fauna & Flora Cambodia and Fauna & Flora Vietnam, and in-country project managers to provide excellent statutory grant management, ensuring sound operational and financial management, in full compliance with Fauna & Flora internal policies and procedures, contracts / grant agreements and relevant statutory and regulatory frameworks, and donor financial guidelines and funding agreements, coordinating technical input from Consortium partners and Fauna & Flora staff from regional, country and cross-cutting teams as appropriate.

#### **Specific Duties:**

#### Programme management

- Provide day to day leadership and direction of all project activities. Develop and update the
  project plan, ensuring that programmatic directions are technically sound, evidence-based,
  and consistent with BLF priorities and outcomes.
- Ensure the project achieves the greatest possible impact including providing the necessary leadership to inspire and motivate the project team to implement performance objectives and mandates in a timely and cost-efficient way and meet the highest quality standards and value for money.
- Collaborate closely with the Fund Manager, the Independent Evaluator, senior Project staff, and with implementing partners and agencies and their respective advisors, to lead the design and operationalise an annual project planning cycle, which formulates comprehensive, integrated annual project workplans, outputs and budgets, taking into account Fauna & Flora's existing approaches to project implementation, and ensure appropriate monitoring and review processes are in place
- Provide leadership to all aspects of the project to ensure highest quality implementation, including final review of detailed budgets, workplans, performance frameworks, MEL plan, procurement and supply chain management plans etc.
- Oversee the inception, integration and delivery of fund activities against the workplan, targets and budgets, coordinating the inputs of regional and cross-cutting teams and partners as necessary and appropriate, taking into account their other programme commitments to ensure effective and timely completion of deliverables.
- Ensure projects are implemented in adherence to DEFRA, the Fund Manager, the Independent Evaluator, and Fauna & Flora's project cycle, operating standards, policies and procedures, to a high quality and to budget and donor requirements
- Manage project inputs from relevant technical and operational staff, consultants and implementing partners, ensuring appropriate contracts are in place where relevant
- Lead Fauna & Flora and donor technical report writing and editing, coordinating the inputs of team members, cross-cutting teams, specialists and partners, ensuring accurate and timely technical reports as per Fauna & Flora and donor requirements
- Work with Country Directors and Director of Operations to support BLF project in-country compliance, including ensuring that third-party approvals necessary for project operations are in place
- Oversee and ensure identification, minimisation and management of safeguarding and human rights issues and risks within BLF programme and the implementation of countryspecific safeguarding priorities

#### Financial management

- Be responsible for the BLF programme budget, financial management and performance, utilising available resources efficiently and effectively
- Maintain oversight to ensure maintenance of project financial records by in-country staff that meet both Fauna & Flora's in-country and UK-based institutional auditing requirements and internal and donor reporting and auditing requirements

#### **Monitoring, Evaluation & Learning (MEL)**

• In collaboration with the MEL Advisor provide leadership and direction to ensure robust monitoring and evaluation strategies, frameworks, plans, systems and indicators to capture and monitor/evaluate project resources, performance and results

- In line with the DoA and relevant country staff members, contribute to the recruitment of any international, UK or in-country staff and consultants required for the effective running of Fauna & Flora's components of the BLF
- Create and sustain a work environment of mutual respect where the project team strives to achieve excellence. Ensure a cohesive workplace for optimum staff retention.

- Establish and maintain strong relationships and effective communication and coordination with relevant personnel from governmental ministries and divisions as well as with other relevant international projects or interventions and incorporate BLF priorities
- Represent Fauna & Flora at appropriate external meetings and fora, relevant conferences and international meetings as required, and particularly with the Fund Manager, and the Independent Evaluator
- Bring to the attention of the Communications Department newsworthy items arising from BLF's work and, as required, develop materials to support DEFRA, and Fauna & Flora's work on the BLF
- Assist in promoting project activities both internally and externally, liaising with and providing written material, and obtaining approval from DEFRA, to Fauna & Flora's Communications Department on project matters

- Proactively develop and nurture relationships with prospective and existing funders and donors, ensuring open and regular communication and hosting donor visits as required, with guidance from fundraising teams

- Provide leadership on shaping partnerships and strategic collaborations needed for delivery
- Oversee risk management areas with the Consortium partners on issues including but not limited to, governance, capacity, financial and grant management, pipeline, operations, health & safety, reputation, social safeguards
