Fauna & Flora

At Fauna & Flora, our shared purpose is to protect the diversity of life on Earth, for the survival of the planet and its people. We work closely with local conservation partners around the world to save nature, together. We harness this collective expertise to inspire positive change globally.

Africa Programme

Working closely with local partners, Fauna & Flora currently operates in 13 countries in West, Central, East and Southern Africa, and is implementing a range of projects focused on species and habitat conservation, biodiversity planning, protected area management, institutional development and capacity building, sustainable use and community-focused wildlife management initiatives. With waterfalls and mountains, deserts and rainforests, wetlands and savannah, Africa is a continent of true splendour. Beneath its wild and ancient landscapes lie resources literally as rich as diamonds, copper and coltan, and its wildlife is as diverse as its cultures. Africa harbours fauna and flora as magnificent as its terrains, including large mammals that occupy huge expanses of land. Mountain gorillas, pygmy hippos, mpingo trees (whose timber is prized for musical instruments) and the desperately rare northern white rhino are just some of the species symbolic of this region. Some of the work currently being undertaken by Fauna & Flora in Africa is the protection of mountain gorillas, African elephants and lions from deforestation and poaching.

South Sudan Programme

Fauna & Flora is bringing its extensive experience of working in conflict and post-conflict countries to South Sudan. We have been working in-country since before its independence (when concern for the fate of this area's wildlife provided the original catalyst for the founding of our organisation) and have managed to maintain a presence despite the ongoing conflict. Our work initially focused on working with the government to restart conservation in the dormant Southern National Park. We also joined forces with the Ministry of Wildlife Conservation and Tourism with the aim of verifying anecdotal sighting of the northern white rhino – one of the last places these animals had been seen in the wild. Sadly, none was found during the extensive search.

In 2013 we were forced to put our work in Southern National Park on hold due to renewed conflict in the area. Since then, we have been focusing our efforts on protecting an important tropical forest area on the border of the Democratic Republic of Congo. This forest corridor is nationally unique and contains chimpanzees, two pangolin species and South Sudan's only population of forest elephants. Despite much tension between people and authorities in South Sudan, we have been able to set up a successful project that sees community wildlife ambassadors and Wildlife Service rangers working together to patrol and monitor the forest. Not only is this helping to reduce threats to biodiversity, but it is also providing a foundation for stability and security in the area.

The Opportunity

Fauna & Flora is seeking an experienced conservation professional to fulfil the role of Project Manager, who will assume responsibility for managing implementation and development of the Bangangai and Bire Kpatou Game Reserves, Western Equatoria State, South Sudan.

The successful candidate will have a substantial proven track record in supporting protected area management, ideally with experience of co-management and development models working with community members, in Africa. They will be skilled in providing strategic advice and technical input to the design, development, implementation, evaluation and reporting for projects and will have excellent project, grant and financial management skills.

Excellent people management skills are essential to the role to ensure a professional and motivated team that delivers effectively against project aims, objectives and timelines. The role also requires a skilled and credible communicator, who is confident in developing and managing relationships with partner organisations and relevant stakeholders, and able to write donor proposals and reports. Additionally, the ability to lead and operate in a conflict / post-conflict situation is essential.

The successful candidate will have a substantial track record in project management, fundraising and capacity building, community mobilisation and engagement as well as a commitment to organisational, donor and legal compliance.

Purpose:

Working closely with the Landscape Manager, Western Equatoria (LM-WE), the Project Manager will support delivery of Fauna & Flora's vision for Western Equatoria landscape by leading the coordination, implementation and monitoring and evaluation of Fauna & Flora supported field activities in specific field sites. Achieving lasting impacts through excellent programme management including maintenance of stakeholder relationships and in full compliance with Fauna & Flora and donor financial guidelines and funding agreements.

Main Duties:

Under the line-management of and in collaboration with the LM-WE and working with the relevant project teams, the Project Manager, Game Reserves will have the following responsibilities:

Implementation and Operations

- Ensure effective and quality planning and implementation of activities to meet agreed project objectives; in line with existing management agreements and agreed best practice measures, and coordinating and accounting for resource availability, including Fauna & Flora staff, partners and other stakeholders. Field activities include but are not limited to:
 - o Developing and improving the protected area management of target sites
 - Technical input into the coordination of law enforcement and biomonitoring patrols and research, and, as required, leading these activities in the field
 - Technical input and support into the establishment and development of other effective area-based conservation measures (OECMs) outside of formally protected areas
 - Overseeing development and maintenance of infrastructure and assets (ranger posts, outposts, roads, bridges, wells, storerooms, motorbikes, radios)
 - Procurement and distribution of supplies and equipment
 - Ensuring that site-level stakeholders, including Wildlife Service rangers, Community Wildlife Ambassadors (CWAs), and local communities, are kept informed of activities and given opportunities to feed into processes and decision making
- Ensure that all activities are delivered in line with agreed timelines and budgets, according to each donor's contractual and administrative requirements, and in compliance with donor and Fauna & Flora operating standards, policies and procedures, and funding agreements

- Ensure all approaches used are those that are standardised across the South Sudan and wider Africa programme, and in collaboration with Fauna & Flora staff and partners in the landscape
- Develop, implement and manage processes for the effective monitoring and evaluation of Fauna & Flora's work in the target sites, ensuring timely adaptation of activities, as required and following Fauna & Flora and donor processes for change, to meet project aims, objectives and timelines, and support the dissemination of lessons learnt
- Ensure that all activities are fully evidenced through excellent record keeping and data storage, in compliance with both Fauna & Flora and donor requirements, to enable regular monitoring and progression of impacts
- Ensure that field operations are conducted to a high standard of health, safety, welfare, environmental good practice and cultural sensitivity, in line with Fauna & Flora global policies and procedures and any national policies and procedures

Development

- Contribute to strategic planning and development of Fauna & Flora's work in the Western Equatoria landscape
- Develop and contribute to funding proposals that meet project outcomes and objectives, ensuring the accuracy and relevancy of work planned, input from relevant staff and partners and that the proposed work is fully aligned with Fauna & Flora's strategy
- Ensure proposal budgets are appropriate for project implementation, address priorities and gaps, consider match funding requirements, and meet staff and field operational costs and institutional overhead requirements

Financial Management and Reporting

- Ensure Fauna & Flora internal reporting requirements and all grant reporting requirements are met in an accurate and timely manner
- Input into the annual budgeting and periodic reforecasting processes for the South Sudan programme

Grant Management

- Represent Fauna & Flora at various partner and stakeholder coordination platforms for successful implementation of landscape activities

- With the agreement of the LM-WE, perform any other tasks that may be requested from time to time that are appropriate to skills and experience
- Provide Fauna & Flora Communications and Fundraising Departments with text and images as required for the production of up-to-date communications and fundraising material (e.g., web pages, articles, reports) to ensure visibility of Fauna & Flora's work in the landscape
- Support a culture of excellent communication, sharing of knowledge, lessons learnt and best practices and collaboration between project staff, wider Fauna & Flora team members, implementing partners and other stakeholders as appropriate
- Work as an active member of the South Sudan and wider Africa team and attend South Sudan and Africa team meetings and work planning sessions as required
- Provide technical input, where appropriate and requested, on other work undertaken by the wider Fauna & Flora Africa programme
